- 4. All proceeds received in the name of the Fund shall be credited to the said account. Funds received in this account shall be utilized solely for the construction of these dams.
- 5. Accounts of the Fund will be maintained, administered and operated by the Registrar Supreme Court under the direct supervision of the Supreme Court of Pakistan.
- 6. This Division's Notification No. No.F.3(1)-PF.V/2018 dated 5th July 2018 shall be treated as withdrawn.
