
SUBJECT:- UNIFORM RATES OF SUBSCRIPTION TOWARDS GENERAL PROVIDENT FUND

The undersigned is directed to refer to Finance Division's O.M. No. F.1(5)-Reg.7/87-301 dated 27th August, 2015 on the above subject and to state that consequent upon the revision of basic pay scales for the civil employees of the Federal Government circulated vide Finance Division's O.M. No.F.1(2)/Imp/2016-333 dated 1st July, 2016, it has been decided to revise the rates of subscription towards General Provident Fund as shown in column 5 of the following table:-

There shall be no option to postpone subscription to the above fund either during leave (except extraordinary leave without pay) or during the training period.
