
Subject:- FURTHER LIBERALIZATION OF LIBERALISED PENSION
RULES FOR CIVIL SERVANTS - FAMILY PENSION.

The undersigned is directed to refer to para 8(2)(b) (i) (ii) of this Division's O.M. No.1(13)-Reg.6/83 dated the 23rd October, 1983 according to which in the event of no pension being payable under clause (a) of the above referred O.M. dated 23.10.1983 the family pension is granted for the period of 10 years or unexpired portion of 40 years :-

(i) to the father;

(ii) failing the father to the mother;

and to say that it has been decided that w.e.f. 1.1.1996 the family pension will be admissible to the father and failing father to the mother for life in the event of no pension being payable under clause (a) of the above referred O.M. dated 23.10.1983.
