**OFFICE MEMORANDUM**

Subject: - **GRANT OF BENEFIT OF BS-19 WITH A NOMENCLATURE OF SENIOR PRIVATE SECRETARY**

The undersigned is directed to refer to the above subject and to say that a number of queries are being received from various quarters regarding rental ceiling for hiring of residential accommodation to Private Secretaries BS-19 with a nomenclature of Senior Private Secretary.

2. It is clarified that grant of the higher time scale i.e. BS-18 /19 to the Private Secretaries (BS-17) is not construed to be a promotion to the post carrying higher pay scale but the higher time scale is treated to be an extension of the post of Private Secretary (BS-17). The substantive pay scale of the Private Secretary remains BPS-17 even after grant of higher time scale i.e. BPS-18/19. In fact, with reference to its status, the grant of higher time scale on completing certain length of service should be treated at par with move over, used to be admissible prior to 01-12-2001. The employees allowed move over were not entitled to any change in Rental Ceiling / House Rent Allowance as clarified by Finance Division's O.M. No. F. 1(7) R-3/85 dated 1<sup>st</sup> August, 1994 (copy enclosed).

OFFICE MEMORANDUM

Subject:- EXTENSION OF THE PRINCIPLE OF MOVE-OVER TO ALL EMPLOYEES OF THE FEDERAL GOVERNMENT.

The undersigned is directed to say that the competent authority has been pleased to decide that Para 1(xi) of the Finance Division's O.M. No.1(82)-R.3/85, dated 1st January, 1986 may be substituted with the following :-

"(xi) The employee allowed to move-over shall not be entitled to any change in rental ceiling. The house rent allowance, which is calculated with reference to the minimum of the relevant basic scale shall continue to be payable on the basis of the minimum of the scale of the post to which the employee originally belongs."

2. It issues with the approval of competent authority and will be effective from the date of its issue.
