2. All proceeds on account of " Prime Minister's Balochistan Earthquake Relief Fund 2013" and payment into the aforesaid Fund will be received at all branches of State Bank of Pakistan, All Treasuries and Branches of National Bank of Pakistan/ other Scheduled Banks.

3. The Fund may receive donations from both domestic, international donors and contributions from abroad which will be received at all the branches as mentioned above In other foreign countries, contributions will be received at Pakistan missions and remitted to the State Bank of Pakistan which would prescribe necessary procedure for their accounting.

4. All proceeds received in the name of the Fund will be credited to the public account of the federal government under following head of account:

5. Accounts of the Fund will be maintained by Accountant General of Pakistan Revenues Islamabad and Fund will be administered by the Cabinet Division in consultation with Finance Division (F.A. Organization).
