It has been decided to establish/open with immediate effect a fund to be known as "PRIME MINISTER'S RELIEF FUND FOR EARTHQUAKE AFFECTEES OF NEPAL-2015" for providing relief assistance to the people affected by the Earthquake in Nepal.

2. All proceeds on account of PRIME MINISTER'S RELIEF FUND FOR EARTHQUAKE AFFECTEES OF NEPAL-2015 and payment into the aforesaid Fund will be received at all branches of State Bank of Pakistan, all treasuries and branches of National Bank of Pakistan and all other Scheduled Banks.

3. The fund may receive donations from both domestic and abroad which will be received at all the branches of above referred banks where such branches are existing. In other foreign countries contributions will be received at Pakistan Missions and remitted to the State Bank of Pakistan which would prescribe necessary procedure for their accounting.
