It has been decided to establish/open with immediate effect a fund to be known as "PRIME MINISTERS'S RELIEF FUND FOR IDPs-2014." for providing relief assistance to the people of North Waziristan Agency which have been displaced from their homes and to mobilize resources and proactively rendering a helping hand in the relief efforts to the peoples affected by the Military operation launched against the terrorists in North Waziristan Agency etc.

2. All proceeds on account of "PRIME MINISTERS'S RELIEF FUND FOR IDPs-2014." and payment into the aforesaid Fund will be received at all branches of State Bank of Pakistan, All Treasuries and Branches of National Bank of Pakistan and all other Scheduled Banks.


3. The Fund may receive donations from both domestic, international donors and contributions from abroad which will be received at all the branches of above referred banks where such branches are existing. In other foreign countries contributions will be received at Pakistan missions and remitted to the State Bank of Pakistan which would prescribe necessary procedure for their accounting.

5. Accounts of the Fund will be maintained by Accountant General of Pakistan Revenues Islamabad and Fund will be administered by the Cabinet Division in consultation with Finance Division (F.A. Organization).
