
Economic Affairs Division(EAD) vide its O.M No.2(27)SEA/Korea/2019, dated 28-03-2019, has informed that Government of Korea through Seoul and Kyung Hee Universities has invited nominations (04-slots) for the fully Funded Master's Degree Program in "**Master of Sustainability and Environmental Policy (MSEP)**" and **Master of Environment and Sustainable Development (MESD)**, under Future Global Leaders in Environmental Policy(MGLEP) to held from August, 2019–July 2020. **Eligibility Criteria**

- Permanent Government Officers(BS-17 and above) nominated by respective Federal government having a minimum 3 years of experience in relevant field.
- Have a Bachelor Degree.
- Be under age 45 years.
- Have a good command of both spoken and written English in order to take classes conducted entirely in English and to be able write academic reports and thesis in English.
- Be in good health, both physically and mentally.
  - ✓ Pregnancy, HIV/AIDS, tuberculosis or any kinds of contagious disease are regarded as a disqualifying condition for the program.
- Not be a person who has withdrawn from KOICA's scholarship program.
- Person belonging to the institution in which candidates submitted false documents and returned to his/her country arbitrarily in the middle of SP program cannot apply.
- Have not participated in KOICA's scholarship program or any of the Korean Government's Scholarship Program before (Master's degree program).
- Have qualified English Proficiency Test(TOEFL/TOEIC/IELTS etc)

2. Interested officers of Finance Division are requested to submit applications duly recommended by the AFS/head of the Wing concerned along with FTC Proforma and copy of CNIC to QA-I Section by **10-04-2019**.

**Note:-** "In addition to the eligibility criteria specified for a training, all officers who are working on contract basis/fixed pay package or having less than two years continuous government service or less than three months of service in Finance Division or against whom disciplinary proceedings/inquiry is in progress, may need not to apply"
