
Objectives:

- To enhance the professional competencies of the participants in managing the fight against corruption. Specifically, the course aims to enable the participants to:
- Understand the causes and effects of corruption and its negative consequences on the well being of the nation and citizens:
- Strengthen technical know how and skills in corruption prevention, detection, investigation, prosecution and community education; and
- Develop an effective anti-corruption strategy; drawing lessons from best (and worst) practices in the region.

Eligibility Criteria:

- The target participants to the course are middle level management government officials engaged in anticorruption work such as Anti Corruption Authorities, Audit Commission, Civil Services Commission, Revenue Collection Agencies, and Enforcement Agencies.
- Participants should be able to attend all the sessions of the course. Successful completion of the course will also require participants to actively participate in the discussions, workshops, case studies, and group work;
- Proficiency in English Language
- Computer Literate
- Preferably University degree holder or equivalent
- age between 26-50 years old
- have not participated in any training program under MTCP (if applicable)

Note:- *“In addition to the eligibility criteria all the Officers who are working in Finance Division on contract basis or on fixed pay package or have completed less than two years continuous service and less than one year service in Finance Division or against whom the disciplinary proceeding/inquiry is in process, may need not to apply”*
