SUBJECT:- AHKNCRD – AARDO Collaborative Regional Training Workshop
“Disaster Risk Reduction and Management” Islamabad, Pakistan (10 – 17
October 2018)

Akhtar Hameed Khan National Centre for Rural Development (AHKNCRD), an attached Department of the Establishment Division, Islamabad vide letter No.1(2)/2018/RO, dated 19-07-2018 has requested to nominate suitable officers for eight days Fully Funded Training program on “Disaster Risk Reduction and Management” from 10th– 17th October, 2018 at Islamabad in collaboration with African-Asian Rural Development Organization(AARDO) headquartered in New Delhi, India. AARDO has 32 member countries from African and Asian Region. The specific Objectives of Workshop are to;

- Discuss the nature of disaster & its impacts on environment, economy and community;
- Discuss the need of creating social infrastructure and developing understanding on community needs for Disaster Risk Management;
- Provide a forum to the participants from AARDO member countries for sharing country specific experiences.

2. The workshop will be attended by experts, senior officials and individuals working in the field of Disaster Risk Management in their respective countries. During the various technical sessions and field visits, the following themes would be covered;


- Basic Terms, Concepts and Disaster Management Cycle;
- Evolution of Disaster Risk Reduction (DRR) in Pakistan and its linkages with international frameworks; and
- Development of Effective Early Warning System for Prevention, Recovery and Rehabilitation.

Essential qualification for Nominees:

- Master / bachelor Degree with a considerable working experience.
- Proficiency in spoken and written English language, being the medium of instruction of the Programme.
- Must be in good health both physically and mentally to undergo the raining programme.

3. Interested officers of Finance Division, who fulfill the given eligibility criteria are requested to kindly furnish their nominations duly recommended by the AFS/ head of the Wing concerned, along with FTC training proforma, to QA-I Section by 31-08-2018.

Note:- “In addition to the eligibility criteria specified for a training, all officers who are working on contract basis/fixed pay package or having less than two years continuous government service or less than three months of service in Finance Division or against whom disciplinary proceedings/inquiry is in progress, may need not to apply”
