Subject:- **TRAINING COURSE ON “Urban Development Towards a Small Nation Vision” to be held from 28<sup>th</sup> January to 1<sup>st</sup> February, 2019 at Singapore under the Japan – Singapore Partnership Programme for the 21<sup>st</sup> Century (JSPP21)**

The Economic Affairs Division vide its O.M No.4(38)SEA-2018 dated 1<sup>st</sup> October, 2018, has requested to nominate officers for **fully Funded** training course offered by the Government of Singapore. The Government of Singapore and Japan will sponsor round trip economy airfares and local hospitality(Local transfers, accommodation, training fee, training allowance and hospitalization insurance). Officers of Finance Division, who fulfill the given eligibility criteria, are requested to furnish their nominations duly recommended by the sAFS/head of the wing concerned alongwith FTC Proforma to QA-I Section by **16-11-2018** positively. The objectives and eligibility criteria of the subject course are as under:-


**Objective :**

- The course will allow participants to understand the driving forces, challenges, and opportunities for sustainable urban development, urban management, and Smart Nation development from both Japan and Singapore. Participants will acquire partial policy application tips through action planning sessions with practitioners and get exposure to case studies of urban development policies in urban domain.

**Eligibility criteria :**

- ❖ Be Government employee (BS-17 and above) only nominated by the respective Federal Ministry.
- ❖ Heading departments or project at a national or city level related to the adaptation and implementation of smart urban solutions, housing, transport, urban renewal/housing, redevelopment, water, waste management or greening. Teams are expected to be headed by Director or DG-level officials and accompanied by a technical officer.
- ❖ Not to be serving in the military.
- ❖ Proficient in spoken and written English.
- ❖ In good health and medically fit to attend the course;
- ❖ Minimum 10 years working experience where possible.

**Note:-** “In addition to the eligibility criteria specified for a training, all officers who are working on contract basis/fixed pay package or having less than two years continuous government service or less than three months of service in Finance Division or against whom disciplinary proceedings/inquiry is in progress, may need not to apply”
