Eligibility Criteria:

- I. Officers (BPS-17 & above / Permanent only) of Ministries/Divisions Departments and Provincial Government most relevant to the training programs.
- II. Maximum age limit 50 years for BS-20 and 45 years for BPS 17-19.
- III. Be in good health and free from any infectious disease with health certificate.
- IV. Proficiency in English
- V. NOC of the department concerned
- VI. Passport having minimum validity of six months
- VII. Contract Employees are not eligible

Expenses:

All the expenses including round-trip air tickets, transit allowance, boarding and lodging in China are to be borne by the Chinese Government.

Note:- "In addition to the eligibility criteria specified for a training, all officers who are working on contract basis/fixed pay package or having less than two years continuous service or less than one year service in Finance Division or against whom disciplinary proceedings/inquiry is in progress, may need not to apply".
