Subject:- **CALL FOR NOMINATION FOR FOREIGN TRAINING PROGRAMS AT MALAYSIA**



<u>Course.3</u> <ul style="list-style-type: none">➤ Be Government Officer(BS-17 and above) only and nominated by respective Federal Govt.➤ Manufacturers, Producers, Heads of Departments, Control Authority or Regulatory, Auditors, Policy Makers, Interested Entrepreneurs and Individuals in related to Food, Healthcare and Cosmetic Industries➤ Certified medically fit both physically & mentally➤ Have good command of S.W English	<u>Course.4</u> <ul style="list-style-type: none">➤ Be Government Officer(BS-17 and above) only and nominated by respective Federal Govt.➤ Co-operative leaders with minimum of three years experience as a board or manager of co-operatives.➤ Medically and physically fit➤ Have good command of spoken and written English➤ Age between 26 to 50 years old➤ Ability to work independently or in groups.

Note:- "In addition to the eligibility criteria specified for a training, all officers who are working on contract basis/fixed pay package or having less than two years continuous government service or less than three months of service in Finance Division or against whom disciplinary proceedings/inquiry is in progress, may need not to apply"
