**Office Memorandum**

Subject: **CLARIFICATION REGARDING EXECUTION OF PSDP FUNDED PROJECT TITLED "CADESTRAL MAPPING" BY SURVEYOR GENERAL OF PAKISTAN (PAO)**


The undersigned is directed to state that the Surveyor General of Pakistan has been designated as the Principal Accounting Officer (PAO) for the PSDP funded Development project titled "Cadastral Mapping", in terms of Section 2(q) of the Public Finance Management Act 2019, vide Finance Division's Notification No. F. 10(33)PFMR-II/2021 dated 8<sup>th</sup> February, 2021. The sponsoring agency for the subject project is Ministry of Planning, Development & Special Initiatives while executing agency is the Survey of Pakistan, Ministry of Defence.

2. During the FY 2020-21 the Project was initially under the Secretary Planning, Development & Special Initiatives as the PAO while after designation of Surveyor General of Pakistan as the PAO, it was directly managed by the office of the Surveyor General of Pakistan under Cost Centre IB2204, Demand # 178.

3. For the FY 2021-22, a new Demand No. 95 "Development Expenditure of Survey of Pakistan", was exclusively created for the project titled "Cadastral Mapping" and it was placed in the Section V under Ministry of Defence as per standard practice. There is no change in the executing and sponsoring agencies of the Project. The Project shall continue to be managed by the Surveyor General of Pakistan as the PAO.

4. The Ministry of Planning, Development & Special Initiatives shall continue to maintain an effective oversight to ensure completion of the project within given timelines and allocated Budget.

5. Accordingly, Demand No. 95, Development Expenditure of Survey of Pakistan (for the Development Project titled "Cadastral Mapping") printed in the Budget Book "Details for Demands for Grants and Appropriations Development Expenditure (Volume-IV) Budget Estimates 2021-22" is placed and shall be read after Demand # 115 under Ministry of Planning, Development & Special Initiatives.
