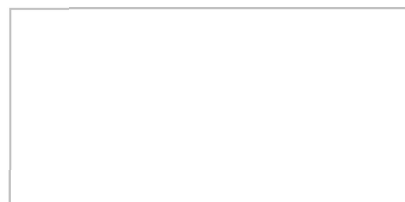
## **OFFICE MEMORANDUM**

**SUBJECT: MEDICAL TREATMENT AT GOVERNMENT EXPENSE OF THE DEPENDENT PARENTS OF GOVERNMENT SERVANT SERVING IN PAKISTAN MISSIONS ABROAD**

The undersigned is directed to refer to this Division's U.O No.715-R-10/84 dated 31-10-1984 regarding the above subject and to state that it has been decided to amend para-1 (iv) of the aforesaid U.O, as follows:-

During stay abroad, the parents would be entitled to ordinary/routine medical treatment at the place of posting. For any special/abnormal or extra-ordinary treatment (including surgery) involving expenditure in excess of **US\$ 1000/-**, would be paid for by the official himself and case for reimbursement would be sent to Ministry of National Health Services and Coordination/Finance Division through administrative Ministry, subject to following conditions:-

- A. The maximum liability of the government in the case of dependent parents of officials/officers will be upto US\$ 15,000/- in each station of the posting and any expenditure beyond this amount will be the officials/officers' responsibility.
- B. Except in emergency cases, the reimbursement of expenditure is not allowed where prior approval of Finance Division has not been obtained.
