DEDUCTION OF ONE DAY'S SALARY OF THE OFFICERS/ OFFICIALS WORKING IN MINISTRIES / DIVISIONS / DEPARTMENTS / AUTHORITIES / CORPORATIONS / COMPANIES/ FINANCIAL INSTITUTIONS/ COMMISSIONS ETC WORKING UNDER THE FEDERAL GOVERNMENT FOR DONATING TO PRIME MINISTER'S RELIEF FUND FOR IDPs-2014

The undersigned is directed to state that the Prime Minister has been pleased to inter alia approve that one day salary of the officers/officials working in the Ministries/ Divisions/ Departments/ Authorities/Corporations/ Companies/ financial Institutions/Commission etc working under the Federal Government may be deducted and donated and deposited towards the Prime Minister's Relief Fund for IDPs-2014.

- 2. The deduction on account of the said contribution will be made at source from the salaries of the officers/officials for the month of June, 2014. The decision will also apply to the officers/officials of the following categories:
 - i) Armed Forces Officers/Officials/Civilian Officers/Officials paid from Defence Estimates if not already deducted.
 - ii) Officers/Officials holding post on contract as well as on lump sum pay package including 'M' Scales and 'MP' Scales and officers/officials locally recruited in our Foreign Missions.
- 3. The amount of contribution shall not be included in the emoluments of the concerned officers/officials for calculation of Income Tax and deduction of the recovery of the House Rent Charges.
- 4. Ministries/Divisions may approach State run Organizations under them, Banks, Financial Institutions, Regulatory Authorities, Telecom Companies, Insurance Companies and other similar organizations for voluntary contributions.
- 5. The Provincial Governments including the Azad Government of AJ & K and Gilgit-Biltistan are also requested to adopt action on the above lines in respect of employees under their administrative control.
- 6. All proceeds received in the name of the Fund will be credited to the public account of the Federal Government under following head of account:
