of post audit by the end of the each month to the concerned DDO".

3. It has been observed that the above-mentioned instructions of the

procedure are not being fully complied with. Non compliance of the instructions shows

that the expenditure from the Assignment Account is not being made according to the

prescribed rules & regulations.

4. All the Ministries/Divisions/Departments are requested to kindly follow

the above-mentioned instructions strictly for proper post audit of the expenditure

incurred from the Assignment Account.
