#### FISCAL PERFORMANCE OVERVIEW - JUL-MARCH FY2025

#### **Revenues:**

#### **Federal Government:**

- (i) FBR collected Rs. 8,453 billion against a target of Rs. 9,168 billion, resulting in a shortfall of Rs. 715 billion.
- (ii) Non-tax revenues amounted to Rs. 4,027 billion, exceeding the target of Rs. 3,956 billion by Rs. 71 billion, due to higher collection of Petroleum Development Levy (PDL) and other non-tax revenues.

#### **Provincial Government:**

- (i) Tax collection was recorded at Rs. 684 billion, surpassing the target of Rs. 606 billion by Rs. 78 billion (13% surplus over the target). This strong performance was primarily driven by the governments of Sindh, Khyber Pakhtunkhwa (KPK), and Balochistan.
- (ii) Non-tax revenues reached Rs. 203 billion, surpassing the target of Rs. 160 billion by Rs. 43 billion an impressive overperformance of 27% increase. This achievement reflects the collective efforts of all provincial governments in enhancing non-tax revenue streams.

#### **Expenditure:**

#### **Federal Government:**

- (i) Primary current expenditures remained well within the targeted ceilings, with actual spending recorded at Rs. 4,313 billion against a target of Rs. 5,221 billion. The primary reason for this was lower releases of subsidies (49% of the allocated target).
- (ii) Development expenditure also remained under the spending target i.e. 317 bn against Rs. 658 bn (48%).

#### **Provincial Government:**

- (i) Provincial current expenditure totaled Rs. 4,006 billion, slightly below the ceiling of Rs. 4,050 billion. Punjab reported savings, while Sindh, KPK, and Balochistan recorded expenditures above their targets.
- (ii) Provincial development expenditure reached Rs. 1,226 billion, exceeding the target by Rs. 104 billion. Overspending was primarily observed in Punjab and Balochistan, while Sindh and KPK remained within their development expenditure targets.
