

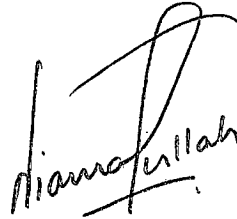

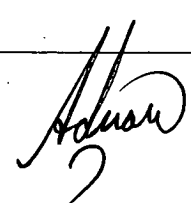

  - ii. Respondent organization must have nationwide presence with a branch office in Islamabad/Rawalpindi.
  - iii. Respondent organization should provide valid company registration certificate in order to prove that the company has been in business/operations for at least last five (5) years.
  - iv. The respondent organization must be an Authorized Partner / Distributor / Manufacturer for the equipment from OEM.
  
- 2- Detailed evaluation** will be conducted for the firms which qualify the preliminary evaluation mentioned above.
  - i. In-depth analysis including authenticity of product, information validity, quality & performance evaluation of equipment.
  - ii. Purchase Committee will examine and verify the compliance with the required specification in demonstration session.

**TERMS & CONDITIONS**

- i. Finance Division will follow single stage two envelop process in accordance with Rule 36(b) of PPRA Rules, 2004. The bid shall comprise a single package containing two separate envelopes. Each envelop shall contain separately the financial proposal and the technical proposal. Each envelop containing the respective proposal should be clearly marked with "Technical Proposal" and "Financial Proposal".
- ii. Interested Company should have a regular place of business with telephone, Fax and email address and must provide proof of their existence in the particular business for not less than five (5) years.
- iii. Price must be quoted in Pak Rupees including GST.
- iv. Each firm is required to offer a warranty period certificate for one year.
- v. The Company should attach the following documents with the technical proposal for participation in bidding process:-
  - a) Earnest Money in favour of Finance Division, Islamabad in the shape of Pay Order / demand draft equal to 2% of total worth of bid has to be attached with the bid. The earnest money will be released after satisfactory completion of warranty period in case of successful bidder. However earnest money of the non-successful bidders will be returned after approval of the case by the Competent Authority.
  - b) Copies of National Tax Number, Sales Tax Registration and Vender Number.
  - c) Affidavit to the effect that the Company has never been blacklisted by any Ministry / Division or Government Department / Organization.
- vi. Bids not accompanied by bid security / earnest money with the technical proposal will not be entertained.
- vii. All admissible taxes shall be deducted at source.
- viii. The equipments to be offered must be as per the enclosed specifications.
- ix. The number of equipments to be purchased can be increased or decreased keeping in view the requirements of this Division and budgetary position.
- x. No cutting / overwriting in the bids will be accepted.

- xi. Bidders do not have the option of submitting their bids electronically. Unsealed bids will not be entertained / received.
- xii. The deadline for the submission of bids is 22<sup>nd</sup> November, 2018 till 1100 hours.
- xiii. Bids received after the due date and time will not be entertained.
- xiv. The financial bids of only technically qualified bidders will be opened. Financial Bids of technically unsuccessful bidders will be returned unopened.
- xv. Minimum threshold for qualification of the technical bids will be 60% marks as per criteria for technical evaluation.
- xvi. The Finance Division will accept lowest evaluated bid as per Rule 38 of PPRA Rules, 2004.
- xvii. The successful bidder shall be responsible for supply the requisite items at **Q-Block**, Pak Secretariat, Islamabad at their own expenses, within 20 days after supply order.
- xviii. The bidding document can also be downloaded from the websites of Finance Division and PPRA.
- xix. It is of utmost importance that bids should be submitted very carefully and the instructions set forth above, scrupulously complied with, failing which the bid will not be entertained.
- xx. Submission of any false statement / documents and concealing of information is likely to disqualify the bidder.
- xxi. In case of unsatisfactory service in any manner including quality and timeline, the bid security / earnest money will be forfeited and contract will be partially / fully cancelled which may lead to blacklisting of the Company.
- xxii. The Finance Division may reject any or all bids / proposals any time prior to acceptance. The ground for rejection of bid or proposal shall be communicated to the bidder upon request without giving justification thereof. Results of bid evaluation shall be announced in accordance with rule 35 of Public Procurement rules, 2004.
- xxiii. The decision of the Finance Division would be final and binding on all matters relating to this tender.
