



Allied Terms & Conditions of Tender Notice for Hardware Module and small UPS

- The firm must have Income Tax registration, National Tax and GST Number.
- Price must be quoted in Pak Rupees and including GST.
- Firms are required to offer one year warranty (with parts) after sale.
- Delivery period shall be one week after issuance of supply order
- Earnest Money in the shape of Pay order / demand draft equivalent to 2% of total worth of bid has to be attached with the bid.
