

**Terms & Conditions of Tender Notice for Hiring of Wagon**

1. The bidders shall provide the following documents/information:
  - a) Name of company, address with telephone/Fax numbers, and contact person.
  - b) An affidavit that the company has not been indulged in litigation with any client during the last five years.
  - c) An affidavit that the company has never been black-listed by any Department / Organization.
  - d) Income Tax Registration Certificate giving National Tax and GST numbers be quoted in the bid / tender.
  - e) Rate on per day basis.
2. The successful bidder shall ensure that the Wagon reaches at the starting point at 7:00 a.m. in the morning regularly on the working days to pick the officials and shall again pick them from 'Q Block' fifteen minutes after office hours for dropping at Rawalpindi.
3. Finance Division has the right to withhold the payments in case the wagon owner fails to adhere to the timings or violate the agreements.
4. All risks involved in the transportation including increase in oil price (if any) shall be borne by the wagon owner. He shall also be responsible to keep the vehicle in good condition during the contract period. Rates are not liable to revision during the currency of the contract period.
5. A bank draft / pay order (fresh) amounting to Rs.10,000/- (Rupees ten thousand only) as Earnest Money must be accompanied with the tender. The earnest money of unsuccessful bidders shall be returned soon after the approval process is completed. The earnest money of the successful bidder shall be retained till expiry of the contract period.
6. Procedure for Hiring of wagon is subject to observance of PPRA Rules.
7. The vehicle should not be older than of 1995 model.
8. Submission of any false statement/documents including concealing of any information is likely to disqualify the bidder.
9. Contract shall be valid for two years from the date of its signing.
10. The contract could be extended for a further period of one year at the existing terms and conditions if mutually agreed.
