SUSTAINABLE RURAL LIVELIHOOD IN KOREA". FERRO, RO KOREA,
SEPTEMBER 3-9, 2023**

Akhtar Hameed Khan National Centre for Rural Development (AHKNCRD) an Executive Department of the Establishment Division, Islamabad vide letter No. 1(4)/2015-16/IL, Trg dated 19th June, 2023 has informed that African Asian Rural Development Organization, (AARDO) New Delhi, India is organizing subject international training programme in collaboration with its Far East Regional office (FERO), and food and Agriculture Organization (FAO) Korea, at FERRO, Republic of Korea, during September 3-9, 2023. AARDO has invited nominations from Pakistan to attend the subject training programme that will be conducted for seven (07) days.

Entitlements:-

- Both ways international airfare from the capital city (Islamabad) to Republic of Korea, and back on an economy class by the shortest possible route;
- Boarding and lodging expenses at the Training Centre
- Expenses on local travel on study tours.

Objectives:-


- Share Korea's experience in achieving sustainable rural development;
- Expose smart agricultural and livestock policies & Programmes;
- Learn Saemaul Movement of Korea;
- Attend Korea International Livestock EXPO 2023.

Eligibility Criteria:-

- Be Director or higher level Government officials/experts working in the areas of policy, programme planner and implementers, responsible for rural/ agricultural Development programme;
- Have proficiency in spoken and written English language as the medium of conducting the programmes will be English only;
- Be in good health both physically and mentally to undergo the course of training.

2. All interested Officers who fulfill the eligibility criteria are required to forward their nomination alongwith FTC Proforma, copy of CNIC & CV duly recommended by the Head of respective Wing to **QA-I Section latest by 10.7.2023**. After approval from FTC the applicant will submit online application at AARDO's website (<https://aardo.org/aardot.php>.)

Note:- "In addition to the eligibility criteria specified for a training, all officers who are working on contract basis/fixed pay package or having less than two years continuous government service or less than three months of service in Finance Division or against whom disciplinary proceedings/inquiry is in progress or on probation period, may need not apply"
