Subject: - **2023 MULTILATERAL TRAINING PROGRAMS UNDER CHINA AID**

The Economic Affairs Division vide its O.M No.3(26) EA/China-II/2023 dated 4.7.2023 states that Government of Republic offered **Seminar on Green and Circular Economy and Sustainable Development start from 30<sup>th</sup> August to 19<sup>th</sup> September, 2023.** The Government of Pakistan will not be liable for any cost. The course contents along with others relevant information are enclosed. The requisite qualification and general requirements are as under:-

**Eligibility Criteria:**

- Officers (BPS-17 & above)
- Proficiency in English.
- Under 45 for director's level and under 50 for director general's level.
- Contract Employees are not eligible.


**Documents Required**

The following documents (**02 sets of each**) are required to be sent alongwith the nomination:

- Application Form
- Information Form duly filled in by the nominee.
- FTC Proforma.
- Copy of CNIC.
- Copy of Passport at least six months of remaining validity and blank visa pages.
- Medical Certificate (Foreigner Physical Examination Form)
- Surety Bond
- Undertaking
- Copy of Covid-19 Full Vaccination Certificate.
- No criminal record / Police character certificate attested by Ministry of Foreign Affairs of Pakistan.

2. Officers of Finance Division, who fulfill the given eligibility criteria, are requested to furnish their nominations duly recommended by the AFS/head of the Wing concerned alongwith required documents to **QA-I Section by 14.7.2023.** Details/ information/ forms / FTC Proforma are available at EAD's website: [www.ead.gov.pk](http://www.ead.gov.pk).

*Note:- "In addition to the eligibility criteria specified for a training, all officers who are working on contract basis/fixed pay package or having less than two years continuous government service or less than three months of service in Finance Division or against whom disciplinary proceedings/inquiry is in progress, may need not to apply".*

About the Organizer	<p>HRC, also called NRIRE, was founded with the joint sponsorship of Chinese government and UN organizations such as UNDP/UNIDO in 1981 in Hangzhou, China, specializing in R+D and training etc. in the fields of renewable energy development including SHP and rural electrification. Entrusted by Chinese Ministry of Water Resources, the Ministry of Commerce, the Ministry of Science &amp; Technology, the Ministry of Foreign Affairs, UNDP, UNIDO, ILO, FAO and ASEAN Secretariat etc., HRC has until now, successfully hosted 152 seminars/training courses for around 5000 participants from 1123 countries regarding the subjects of water resources, small hydropower, rural electrification, climate change, etc. Meanwhile, HRC hosted over 30 international meetings or conferences in China and abroad, such as "Second International SHP Seminar" in Hangzhou, "International Seminar for S&amp;MHP" in Brazil, "Promotion Conference for Clean Energy Development" in Macedonia, "Seminar on Small Hydropower and Rural Electrification" in Tanzania, and "International Symposium on Greening and Upgrading Small Hydropower for Eco-environment Restoration" in Lishui, etc. and approved to be "International S+T Cooperation Base of Zhejiang Province for Renewable Energy and Rural Electrification". It is also renowned as the "Family of SHP in the World" and certified as the "Model of South-South Cooperation" of the Ministry of Commerce of China.</p>

Seminar Content	<p>Seminar on Green and Circular Economy and Sustainable Development will be held in Hangzhou, China from August 30 to September 19, 2023, lasting for 21 days. The working language is English. The course arrangement of the seminar include technical lectures, field visits, discussions and exchanges, cultural experience, etc. The topics of the lectures cover China's concept of green development, practice of green, low-carbon and circular development, research on market mechanism and policy of low-carbon economy, development and application of clean energy, local practice of carbon peaking and neutrality and ecological construction in Zhejiang Province, etc. The destinations for field visits include Yucun Village in Anji, Liandu zero-carbon scenic spot in Lishui, Wuzhen Internet Town, provincial photovoltaic power generation application demonstration town, Shanghai Electric Group, etc. In addition, the seminar will organize discussions and exchanges, and invite relevant organizations, enterprises to have discussions on relevant topics with seminar participants, so as to enhance mutual understanding and meet the needs of cooperation. In addition, in order to enrich the extra curriculum life of participants and help them understand China's national conditions and time-honored Chinese culture, Chinese cultural experience activities such as night tour along the Huangpu River and Chinese silk and tea culture will be arranged. Through the seminar, participants will learn about China's development concepts, management policies, mature technologies and practical experience of green circular economy, which is Chinese solutions, Chinese wisdom and Chinese technologies for the reference of developing countries for green and sustainable development. The seminar will also aim to strengthen communication and friendship, and lay a good foundation for exchanges and cooperation between developing countries in the field of green and sustainable development.</p>
