Subject: **AARDO-MARDI INTERNATIONAL ONLINE TRAINING PROGRAMME ON "AGRICULTURAL NANOTECHNOLOGY: CATALYSING FOOD SECURITY AND SUSTAINABILITY", MARDI, MALAYSIA, JULY, 01-05, 2024**

Akhtar Hameed Khan Asian Rural Development Organization, (AARDO), an Executive Department of the Establishment Division, Islamabad vide letter No. 1(4)/2015-16/IL,Trg dated 24th April, 2024 has informed that African Asian Rural Development Organization, (AARDO) New Delhi, India is organizing an **online** subject international training programme in collaboration with the Malaysian Agricultural Research Development Institute (MARDI), Malaysia, during July 01-05, 2024. AARDO has invited nominations from Pakistan to attend the subject training programme that will be conducted for five working days (total 10 Hours, two hours' session on each day). The session timings will be 1430-1630 hrs. IST (1400-1600 hrs. PST).

Objectives:-


- Share the experiences and current state of Malaysia's agriculture nanotechnology in addressing food security and sustainable future.
- Establish an efficient networking among participants from all member countries for future research and technical collaborations.

Eligibility Criteria:-

- Be a Government Officer (BPS-17 or above).
- Have bachelor's degree with a minimum of three years' experience in the concerned fields.
- Have proficiency in spoken and written English language as the medium of conducting the programmes will be English only; and ,
- Be conversant with ICT and willing to undertake online training programme.

2. All interested Officers (BPS-17 & above) of Finance Division are requested to furnish their nominations duly recommended by the AFS/head of the Wing concerned, to **QA-I Section by 27.5.2024**. After approval of the (Competent Authority) the applicant will submit online application at AARDO's website (<http://aardo.org/formDD.php>). Note:- "In addition to the eligibility criteria specified for a training, all officers who are working on contract basis/fixed pay package or having less than two years continuous government service or less than three months of service in Finance Division or against whom disciplinary proceedings/inquiry is in progress or on probation period, may need not apply"
