SUBJECT: - **IN-PERSON COURSE MARITIME SAFETY MANAGEMENT SINGAPORE COOPERATION PROGRAMME AND THE JAPAN INTERNATIONAL COOPERATION AGENCY UNDER THE JAPAN- SINGAPORE PARTNERSHIP PROGRAMME FOR THE 21<sup>ST</sup> CENTURY (JSPP-21) TO BE CONDUCTED BY THE MARITIME AND PORT AUTHORITY OF SINGAPORE ACADEMY TO BE HELD FROM 8<sup>TH</sup> TO 12<sup>TH</sup> JULY, 2024**

The Economic Affairs Division vide its O.M No.4 (17) SEA//2024 dated 2<sup>nd</sup> May, 2024 has informed that the Government of Singapore has invited **Two (02)** nominations for the above **(Fully Funded)** training course. The Government of Singapore will bear the full expenditure course fee for successful. The eligibility criteria and objectives of the subject course are as under:-

**Eligibility Criteria:**

- Mid-to senior level government officers who are working in port and maritime-related roles;
- Nominated by their respective governments;
- Proficient in written and spoken English; and
- In good health.

**Objective:**

- This in-person course is conducted under the auspices of the Japan-Singapore Partnership Programme for the 21<sup>st</sup> Century (JSPP-21). This course aims to share the experience of Singapore and Japan in maritime safety management.
