Subject: - TRAINING COURSE ON “CAPACITY BUILDING FOR FORMULATING AND EVALUATING ECONOMIC DEVELOPMENT STRATEGY AND POLICY IN PAKISTAN (23-25)” TO BE HELD FROM 26TH TO 30TH AUGUST, 2024 (ONLINE) 1ST TO 12TH SEPTEMBER 2024 (INVITATIONAL) IN KOREA

Economic Affairs Division vide its O.M No. 2(10) SEA/Korea/2024 dated 4th June, 2024 has informed that Korea International Cooperation Agency (KOICA) has invited (15) nominations for the above **(Fully Funded)** training Programme to be held from 26th to 30th August, 2024 (Online) and 1st to 12th September, 2024 (invitational) at Republic of Korea.

Eligibility Criteria:

MANDATORY	<ul style="list-style-type: none"> • Participants must be nominated by his/her government; • Participants' works must be related to the Economic Affairs; • (Original Place of employment) Ministry of Economic Affairs and /or relevant departments; • (Position) Be a government employee in a high-level position; • Must be in good health both physically and mentally, enough to take the course; • Have a willingness to show active participation and commitment throughout the course and contribute to the capacity building of his/her organization after the completion of the program; • Have not participated in the same or similar KOICA Fellowship Program for the past three years, unless otherwise specified; (provided, however that a key person for the course of the intensive performance management program, for example, may participate in the same or similar KOICA Fellowship Program, subject to pre-discussion with KOICA.); • (Language capability) Sufficient proficiency in written and spoken English to actively participate in seminars and write an Action Plan; • (Full-time Participation) Be able to attend the KOICA Fellowship Program full-time; • (IT literacy) Have working knowledge of computers and related digital technology and perform basic tasks such as operating software systems, platforms and other communication programs (Windows, MS Office, email, etc.);
RECOMMENDED	<ul style="list-style-type: none"> • (ICT Environment) Have easy access to internet and be able to navigate online for the online pre-training. • (Gender balance) The proportion of female participants is highly recommended to be more than 40% of total participants.

Objectives:

- Looking for effective economic development strategies and evaluation measures to cope with economic crisis.
- Securing sustainability of national debt through effective foreign debt management.
- Strengthening the professional capabilities for economic policy making and analysis, performance evaluation and feedback.
- Strengthening the leadership and accountability of high-level officials of economic ministries
