- Permanent Government Officer (BS-17 and above) nominated by respective Federal/ Provincial Government
- Minimum 2 years of experience in relevant field.
- Be under 40 year of age on February 1, 2022 (Preferably)
- Be in good health, both physically and mentally.
- Bachelor Degree or an equivalent to University level Educational background.
- English Language Proficiency proof/English Language Test score as per attached course document.
- Not be a person who has withdrawn from KOICA's scholarship program.
- Have not participated in any of the Korean Government's Scholarship Program before (Other detail available in each specific course document uploaded).



2. Interested Officers of Finance Division (serving on regular basis) may submit applications duly recommended by the AFS concerned along with FTC Proforma and copy of CNIC to QA-I Section by **21st February, 2022** Positively to QA-I section.

Note:- "In addition to the eligibility criteria specified for a training, all officers who are working on contract basis/fixed pay package or having less than two years continuous government service or less than three months of service in Finance Division or against whom disciplinary proceedings/inquiry is in progress or on probation period, may need not to apply"
