Eligibility Criteria:


- Permanent Government Officer (BS 17 & above) of Finance Division.
- Candidates should be preferred working in the government sector or in the area which related to the course was provided.
- Candidates must have Bachelor's degree and / or professional experience related field or related to graduate degree.
- Candidates must have a good command of English.
- Candidates whose first language is not English and Bachelor's degree was not instructed in English, have to pass an English Language proficiency test according to criteria required by the academic institution regulations.
- Candidates must be no more than 45 years of age.
- Candidates must have good physical and mental condition and must not be pregnant.
- TICA reserve the rights to revoke scholarship offered to awardees who violate rules and regulations.
- Other requirements apart from these will be under consideration by the University regulations.
