- Have not participated in the same or similar KOICA Fellowship program from the past three years.
- Sufficiency proficiency in written and spoken English to actively participate in seminars and write an Action Plan.
- Be able to attend the KOICA Fellowship Program full-time.

- Look for effective economic development strategies and evaluation measures to cope with economic crisis.
- Securing sustainability of national debt through effective foreign debt management.
- Strengthening the professional capabilities for economic policy making and analysis, performance evaluation and feedback.
- Strengthening the leadership and accountability of middle managers of economic ministries
