- Have proficiency in spoken and written English language as the medium of conducting the programmes will be English only;
- Be in good health both physically and mentally to undergo the course of training; and;
- Be below 50 years of age.

All interested Officers who fulfill the eligibility criteria are required to forward their nomination alongwith FTC Proforma, copy of CNIC & CV duly recommended by the head of respective Wing to QA-I Section latest by 16.10.2023. After approval from FTC the applicant will submit online application at AARDO's website (https://aardo.org/aardot.php.)

Note:- "In addition to the eligibility criteria specified for a training, all officers who are working on contract basis/fixed pay package or having less than two years continuous government service or less than three months of service in Finance Division or against whom disciplinary proceedings/inquiry is in progress or on probation period, may need not apply"
