Subject: **NOMINATION FOR POST GRADUATE DIPLOMA IN RURAL DEVELOPMENT MANAGEMENT – NATIONAL INSTITUTE OF RURAL DEVELOPMENT AND PANCHAYATI RAJ (NIRD&PR) INDIA ACADEMIC YEAR 2025-26 SPONSORED BY MINISTRY OF RURAL DEVELOPMENT, GOVERNMENT OF INDIA**

Akhtar Hameed Khan African Asian Rural Development Organization, (AARDO), an Executive Department of the Establishment Division, Islamabad vide letter No. 1(4)/2014-15/Trg/CIRDAP dated 24<sup>th</sup> Feb, 2025 has informed that the Centre on Integrated Rural Development for Asia & the Pacific (CIRDAP), Dhaka, Bangladesh, is sponsoring (one year) post graduate diploma for subject-titled Programme at National Institute of Rural Development & Panchayati Raj, Rajendranagar, Hyderabad, India.

2. It is stated that the shortlisted candidates will be interviewed through teleconferencing / videoconferencing jointly by CIRDAP and NIRD&PR. The Ministry of Rural Development, Government of India, will cover all the expenses for selected international in-service students, including reimbursement of air travel costs (as per Gol norms) after joining the programme. Hence the **Proficiency of students in writing and spoken English is compulsory.**

**Eligibility Criteria:**

- Officials working in Agricultural, Rural Development and allied sectors;
- Must have work experience in the Rural Sector.

2. All interested Officers who fulfill the eligibility criteria are required to forward their nomination alongwith FTC Proforma, copy of CNIC & CV duly recommended by the Head of respective Wing to **QA-I Section by 7.4.2025**. The application form can be downloaded from [www.nirdpr.org.in](http://www.nirdpr.org.in).

**Note:-** "In addition to the eligibility criteria specified for a training, all officers who are working on contract basis/fixed pay package or having less than two years continuous government service or less than three months of service in Finance Division or against whom disciplinary proceedings/inquiry is in progress or on probation period, may need not to apply"
