**CIRCULAR**

Subject: **INTERNATIONAL TRAINING PROGRAMME ON “RURAL TRANSFORMATION: THE MALAYSIAN EXPERIENCE” INFRA, KUALA LUMPUR, MALAYSIA, SEPTEMBER 19-29,2023**

Akhtar Hameed Khan National Centre for Rural Development,(AHKNCRD), an Executive Department of the Establishment Division, Islamabad vide letter No. 1(4)/2015-16/IL,Trg dated 9<sup>th</sup> June, 2023 has informed that African Asian Rural Development Organization (AARDO) New Delhi, India is organizing subject international training porgramme in collaboration with the Institute for Rural Advancement (INFRA), Kuala Lumpur, Malaysia, during September 19-23, 2023. AARDO has invited two nominations from Pakistan to attend the subject training programme that will be conducted for (11) week days.

**Entitlements:-**

- Both ways international airfare from the capital city (Islamabad) to Kuala Lumpur, Malaysia and back on an economy class by the shortest possible route;
- Boarding and lodging expenses at the Training Centre;
- Tuition fee, books and literature;
- Expenses on local travel on study tours.

**Objectives:-**


- Understand rural development policies, strategies and progmmes especially in Malaysian experience;
- Share successes, best practices and lessons learned from rural development programmes implemented in Malaysia, particularly those aimed empowering the poor through income generation programmes and value-added projects.
- Enable participants to exchange views on practical knowledge, technology transfer, income generation activities, and environmental improvement for better quality of life in rural areas;
- Promote collaboration and networking among key personnel in rural development and poverty alleviation from participating countries.

**Eligibility Criteria:-**

- Be middle and senior level Government official working in the areas of policy, programme planner and implementers, responsible for rural / agricultural development programme.
- Have proficiency in spoken and written English language as the medium of conducting the programmes will be English only;
- Be in good health both physically and mentally to undergo the course of training;
- Be preferably up to 50 years of age.

2. All interested Officers (BPS-17 & above) who fulfill the eligibility criteria are required to forward their nomination alongwith FTC Proforma, copy of CNIC & CV duly recommended by the Head of respective Wing to **QA-I Section latest by 26.6. 2023.** After approval from FTC the applicant will submit online application form using the link <https://mtcp.kln.gov.my/mtcpforms/MTCP2023BORANG PEMOHONAN AARDO INFR A.pdf>.

*Note:- "In addition to the eligibility criteria specified for a training, all officers who are working on contract basis/fixed pay package or having less than two years continuous government service or less than three months of service in Finance Division or against whom disciplinary proceedings/inquiry is in progress or on probation period, may need not to apply"*
