Subject: - **2023 MULTILATERAL TRAINING PROGRAMS UNDER CHINA AID (OCTOBER-DECEMBER)**

The Economic Affairs Division vide its O.M No.2(1) EA/China-II/2023 dated 12 September, 2023 states that Government of Republic China has Offered **fully funded Multilateral Training Courses / Seminars in different disciplines for the year 2023** for officers of Government of Pakistan (**List Attached**). The Government of Pakistan will not bear any cost. The requisite qualification and general requirements are as under:-

**Eligibility Criteria:**

- Officers (**BPS-17 & above**).
- **Contract Employees are not eligible.**
- **Employees on probation are also not eligible.**
- **Age limit: 45 years for BPS-17-19 and 50 year for BPS 20-22.**

**Documents Required**

The following documents (**02 sets of each**) are required to be sent alongwith the nomination:

- Application Form
- Information Form duly filled in by the nominee.
- FTC Proforma.
- Copy of CNIC.
- Copy of Passport at least six months of remaining validity and blank visa pages.
- Medical Certificate (Foreigner Physical Examination Form)
- Surety Bond
- Undertaking
- Copy of Covid-19 Full Vaccination Certificate.
- For candidates having ordinary passport, Police Character Certificate attested by Ministry or Foreign Affairs of Pakistan will be needed. For official passport holders, attestation by Ministry of Foreign Affairs is not required.

2. Officers of Finance Division, who fulfill the given eligibility criteria, are requested to furnish their nominations duly recommended by the AFS/head of the Wing concerned alongwith required documents to **QA-I Section**. **Note:-** "In addition to the eligibility criteria specified for a training, all officers who are working on contract basis/fixed pay package or having less than two years continuous government service or less than three months of service in Finance Division or against whom disciplinary proceedings/inquiry is in progress, may need not apply".
