  - Be a government Officer (BPS-17 or above) or middle or senior level executives from Ministries/Divisions/Attached Department, Provincial Governments or Public-Sector Universities;
  - Have a bachelor's degree or its equivalent, with considerable working experience in planning and executing the programmes related to the subject of the programmes;
  - Be subject specialist and related to the subject of the programmes;

#### From Pre-Page

- Have proficiency in spoken and written English language as the medium of conducting the programmes will be English only;
- Be below 55 (fifty-five) years of age with no participation in AARDO's offline programmes over the last two years; and ,
- Be in good health to undergo the programme.
