Subject: - **E-LEARNING COURSE ON “INTERNATIONAL ARBITRATION AND MEDIATION” TO BE CONDUCTED FROM 5TH TO 7TH SEPTEMBER, 2022, UNDER THE JAPAN-SINGAPORE PARTNERSHIP PROGRAMME FOR THE 21ST CENTURY (JSPP21).**

The Economic Affairs Division vide its O.M No.4 (21) SEA/2022 dated 20TH July, 2022 has informed that the Government of Singapore has invited two (2) nomination for the above training course offered by the Government of Singapore. The objectives and eligibility criteria of the subject course are as under:-

Eligibility Criteria:

- Mid-to-senior level government officials who are involved in work related to dispute management and resolution in the area of business and related to business transaction, trade or investment.
- Able to attend all the live synchronous e-learning sessions. They will require an internet enable device with a functioning webcam, microphone and audio.
- Nominated by their respective Governments.
- Proficient in written and spoken English.
