Eligibility Criteria:-

- ➤ Be Young public administrators and government officers who are expected to play active roles in future as national leaders.
- ➤ Have at least 3 years of full-time work experience in total as of October 1, 2025 in public administration (preferably 5 years or more)
- ➤ Be under 40 years age of 1st October, 2025 (i.e. born on or after October 2,1985).
- ➤ Have Bachelor's degree or equivalent, from a recognized / accredited university or college with excellent academic performance.
- ➤ Be proficient in English (with a TOEFL-iBT score of 79, IELTS Academic score of 6.0 or equivalent)
- > Be in good health, both physically and mentally to participate in the program
- ➤ Not be military personnel or military –civilian employees.
