Subject: - **JAPANESE GOVERNMENT MEXT SCHOLARSHIP UNDER YOUNG LEADERS' PROGRAM (YLP) FOR YEAR 2025 AT SCHOOL OF LOCAL GOVERNANCE AND SCHOOL OF GOVERNMENT**

The Economic Affairs Division vide its O.M No.1(52)Japan-II/2024 dated 22.7.2024 has informed that the Japanese government, Ministry of Education, Culture, Sports Sciences and Technology (MEXT) has offered the one-year scholarship program in the field of “**School of Local Governance**” and “**School of Government**” to study at GRIPS University as YLP students in public administration/public policy, scheduled to be held w.e.f **October 2025 to September 2026 in Japan.**

**Objective:**

- Young Leaders' Program (YLP) aims to contribute to cultivate future national leaders in Asian and other countries, moreover, to contribute to establish friendly relationships among various countries and to improve policy planning activities by forming a network among national leaders through deepening their understanding of Japan.

**Eligibility Criteria:-**

- Be Young public administrators and government officers who are expected to play active roles in future as national leaders.
- Have at least 3 years of full-time work experience in total as of October 1, 2025 in public administration (preferably 5 years or more)
- Be under 40 years age of 1<sup>st</sup> October, 2025 (i.e. born on or after October 2, 1985).
- Have Bachelor's degree or equivalent, from a recognized / accredited university or college with excellent academic performance.
- Be proficient in English (with a TOEFL-iBT score of 79, IELTS Academic score of 6.0 or equivalent)
- Be in good health, both physically and mentally to participate in the program
- Not be military personnel or military –civilian employees.
