- Be in good health both physically and mentally to undergo the programme:
- Be preferably below 50 years of age.

Entitlements:-

Sponsorship from AARDO will cover both ways international airfare from the capital city of the nominee Islamabad to Hyderabad, India, and back on an economy class by the shortest possible route. AARDO will also bear costs of boarding & lodging during the event (excluding expenses on laundry, phone calls, etc.). However, our-of-pocket allowance, expenses on obtaining a passport, visa, airport tax, transit and medical expenses, etc. are not admissible.
